A bespoke florist and botanically inspired gift store situated in the Sandton, offers a full floristry and gifting service. This florist boasts a number of corporate clients and an online store.

How does the business operate on a daily basis?

They service a number of corporate clients on a weekly and ad hoc basis as well as servicing private clients. This florist has a great location with high visibility on a busy road in close proximity to Sandton CBD. The florist also fulfils orders received via their online store.

What Advertising/Marketing is carried out?

Mostly social media (facebook and instgram) as well as local neighbourhood whatsapp groups.

What competition exists?

There are other florists in the area, however these are more retail orientated, whereas this company's primary focus is on servicing corporates in and around Sandton.

How could the profitability of the business be improved?

The profitability of the florist could be improved through increased marketing spend and running social media campaigns. Also huge opportunity to branch into weddings and floral workshops.

Give a breakdown of staff/functions/length of service?

One florist has been with the business since inception, 7 years ago.

One florist has been with the business for 2.5 years.

Both florists are highly skilled in all aspects of floristry and can work without supervision.

Both florists double as sales assistants, assisting walk in clients with flower and gift selection, ringing up sales, gift wrapping etc.

The one florist is also acts as delivery person/driver, using the company vehicle to do flower deliveries. Both florists know the running of the business well, are very well liked by our clients and customers and essentially they are the heart of the business.
