Fully describe the business's activities?

This Franchised Fuel Retail business was initiated in 1984, on the owner's property. It is situated on a busy corner of two major access roads. There is a "retail shop" that serves customers on site, fast foods, groceries, and products that customers request (sweets, cigarettes, cool drinks etc.) The Service station supplies petrol, diesel, oils etc. Open 24/7.

How does the business operate on a daily basis?
